



EXECUTIVE ORDER NO. 17

"AN ORDER RECONSTITUTING THE SECTORAL/FUNCTIONAL COMMITTEES OF THE MUNICIPAL DEVELOPMENT COUNCIL OF PALO, LEYTE"

WHEREAS, Republic Act 7160 otherwise known as The Local Government Code of 1991 mandates the creation of a Municipal Development Council, responsible for the comprehensive multi-sectoral development plan of the local government unit.

WHEREAS, the municipal development council shall assist the Sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction.

WHEREAS, Sections 106-115 of the Local Government Code of 1991 provides for the composition, functions, representation of non-governmental organizations, meetings and quorum, executive committee, sectoral or functional committees, and secretariat of the Municipal Development Council.

WHEREAS, NOW THEREFORE, I, FRANCES ANN B. PETILLA, Municipal Mayor of Palo, by virtue of the power vested in me by law, do hereby reconstitute the Sectoral or Functional Committees of the Municipal Development Council of the Municipality of Palo, Leyte;


Section 2. Functions of the Sectoral or Functional Committees.

- a) Assist the MDC in the performance of its functions;
- b) Provide the MDC with data and information essential to the formulation of plans, programs and activities;
- c) Define sectoral or functional objectives, set targets, and identify programs, projects and activities;
- d) Collate and analyze data and conduct studies;
- e) Conduct public hearings on sectoral planning, project and activities; and
- f) Monitor and evaluate programs and projects among others.

Section 3. Repealing Clause. All orders, issuances, rules and regulations or parts thereof inconsistent with this Executive Order are hereby repealed or modified accordingly.

Section 4. Effectivity. This Order shall take effect immediately.
